

AVOCADOS FROM MEXICO™ SOCIAL MEDIA GIVEAWAY

OFFICIAL RULES

NO PURCHASE NECESSARY. PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

1. **PROMOTION DESCRIPTION:** The **Avocados From Mexico™ Social Media Giveaway** (the “**Sweepstakes**”) is a social media Sweepstakes that begins on 7/23/24 at 1:00:00 PM Eastern Time (“**ET**”) and ends on 7/31/24 at 11:59:59 PM (ET) (the “**Promotion Period**”). The designated computer clock of the Administrator is the official time-keeping device in the Sweepstakes.

Throughout the Promotion Period, eligible entrants will have the opportunity to follow the **Avocados From Mexico** account on Instagram (@avocadosfrommexico); like the Sweepstakes post made on 7/23/24 by the **Avocados From Mexico** account on Instagram; tag two (2) friends and post a comment using the hashtag #sweepstakes (“**Hashtag**”) (collectively, the “**Submission**”) to enter the Sweepstakes. There will be thirty (30) Grand Prize winners for the Sweepstakes that will be randomly selected at the conclusion of the Promotion Period. Entry details, prize information and restrictions are more fully set forth below.

By participating in the Sweepstakes and posting a Submission using the “Hashtag”, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the Avocados From Mexico (“**Sponsor**”), which shall be final and binding in all respects.

2. **ELIGIBILITY:** Sweepstakes is open only to legal residents of the fifty (50) United States and District of Columbia and are eighteen (18) years of age or older at time of entry. Employees of Avocados From Mexico, its parent company, their subsidiaries, affiliates, advertising, promotion and other agencies (collectively, the “**Promotion Entities**”), and their immediate family members and/or those living in the same household of each are not eligible to participate. You must follow @avocadosfrommexico on Instagram, like the Sweepstakes post made on 7/23/24 by the **Avocados From Mexico** account on Instagram; you must tag two (2) friends and you must post a comment using the Hashtag for your Submission to be eligible as an entry into the Sweepstakes. You must be a registered Instagram member to

enter via the Instagram method of entry. Instagram account registration and Sweepstakes entry is free.

Direct any questions, comments, or complaints regarding the Sweepstakes to Sponsor, not Instagram. Limit one (1) entry per person/social media account in the Sweepstakes.

Each Submission must meet the following “**Submission Requirements**” (any Submission that, in Sponsor’s sole and absolute discretion, violates the following criteria will be disqualified):

- Submission must be posted by a non-private social media account in response to the **Avocados From Mexico** account on Instagram; the social media account associated with this Sweepstakes can be obtained for free at the social media platform or in the applicable app store;
- Entrant must be the rightful owner of the social media account associated with the Submission;
- Submission must comply with the social media platform’s terms and conditions as posted on the respective social media platform;
- Submission must NOT contain subject matter which is, or could be considered, in the sole discretion of the Promotion Entities, obscene, pornographic, violent (e.g., relating to murder, the sales of weapons, cruelty, abuse, etc.), defamatory, libelous, discriminatory (based on race, sex, religion, natural origin, physical disability, sexual orientation or age), illegal (e.g., illegal gambling, underage drinking, substance abuse, computer hacking, etc.), offensive, threatening, profane, hateful, degrading, harassing, or otherwise unlawful, tortious or objectionable;

Any potential winner will be the entrant of the Submission that is associated with an entry that is randomly selected as a winning entry, subject to eligibility verification. Potential winner will be notified via direct message within seven (7) days of the random drawing with instructions on how to verify eligibility and claim the prize using contact information provided or collected at the time of entry. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by the potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within two (2) business days of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate winner may be selected. By participating in the Sweepstakes, each entrant unconditionally warrants that his/her Submission complies with and abides by the submission requirements as provided in the Official Rules. Each entrant hereby agrees to indemnify and hold the Promotion Entities harmless from and against any and all third-party claims, actions or proceedings of any kind and from any and all damages, liabilities, costs and expenses relating to or arising out of any breach or alleged breach of any of the warranties, representations or agreements of entrant hereunder.
